The responsible person for students with disabilities and/or physical illness is part of the Office of the Chair of the Academic Board, and the first point of contact and central information source for all matters related to studying with disabilities and/or physical illness and requirements.

A good start to student life takes careful preparation

Disabilities are as varied as personalities – IMC Krems is committed to finding practicable, innovative and tailored solutions for students with disabilities and/or physical illness and requirements.

Disability or chronic illness is no barrier to successfully completing a degree at IMC Krems. Many potential obstacles can be removed given adequate preparation, the right support and special regulations. Our disabilities and/or physical illness support person is at hand to make sure that the facilities you find in place at IMC Krems are optimised to the fullest possible extent, to enable you to study and finish your degree successfully.

This is why notifying the support person or the Office of the Chair of the Academic Board of any disability or illness in good time is so important – especially if your particular condition is not immediately apparent to others. We will only be able to take your special requirements into account if you let us know about them in advance or in due time.

It goes without saying that any information you share with us will be kept confidential. Nevertheless, if you still feel uncomfortable talking about your disabilities and/or physical illness, you also have the option of informing the support person anonymously. Anonymous telephone and e-mail support is also available.

Under what circumstances should you contact the support person for Students/Applicants with Disabilities and/or physical illness?

If you are already studying at IMC Krems or are planning to enrol on a degree programme in the near future and feel that your disability or illness has an impact on your ability to study, you should contact the support service. It provides support and advice on:

- Mobility impairment
- Hearing impairment
- Speech impairment
- Chronic illnesses or other long periods of illness which can have a detrimental impact on your ability to participate in your degree programme
- Learning disabilities such as dyslexia or dyscalculia

Available support

The following support is offered by IMC Krems:

- Adapted processes for applicants and students with disabilities and/or physical illness
- Alternative admissions procedure (for applicants with a medical report from a specialist)
- Alternative examination format throughout the degree programme (certificate from specialist required)
- Support and information on degree-programme-related questions connected with the disability and/or chronic illness concerned

IMC Krems facilities

- Barrier-free access for people with mobility impairment
- Step-free lift access throughout IMC Krems buildings
- Barrier-free toilets
- Tactile signage system in parts of the main section of the IMC Krems campus
- Barrier-free access to vending machines
- Barrier-free access to parking
- Barrier-free access to lecture theatres

Good to know

Students with disabilities and/or physical illness also have the opportunity to take examinations in a different format if the standard procedure is not an option due to their particular requirements. Options include oral instead of written examinations, if the student is unable to write or has difficulty in writing. Students can also request additional time for examinations.
